**ITEM 5 SUPPLEMENTS AND REISSUES**

When reference is made in this tariff, or supplements, to other publications for rates or other information, it includes "Supplements" thereto or successive issues thereof. As this tariff is supplemented, numbered items with letter suffices cancel correspondingly number items in the original Tariff, or in a prior supplement. Letter suffices will be in Alphabetical sequence starting with A. Example: Item 100A cancels Item 100; and Item 300-B cancels Item 300-A in a prior supplement, which in turn cancelled Item 300.

All charges under this tariff must be prepaid, unless satisfactory arrangements with ISW have been made prior to performance of Service. Charges for services rendered under terms of this tariff will accrue against the customer located on the ISW unless arrangements to the contrary have been made with ISW prior to performance of service.

All payments for services covered herein are due and payable within fifteen (15) days following the Freight Bill date. The rules Applicable to payments and credit terms are in accordance with those found in 49 CFR 1320. Payments received after the expiration of the credit period shall be subject to a service charge of one and one-half percent (1-1/2%) per month (or fraction thereof) of the outstanding balance.

**Application and Definition of Intermediate Switching**

A switching movement of cars from the interchange tracks of one connecting carrier to the interchange tracks of another connecting carrier within the switching limits of the same station on which the switch carrier neither originates nor terminates the shipment nor receives a line-haul.

**INTERMEDIATE CHARGES APPLY IN EACH DIRECTION, AND WILL BE PAID TO ISW AS NOTED BELOW.**

**ALL CHARGES ARE IN DOLLARS AND CENTS PER CAR AND WILL APPLY AND BE ASSESSED BY ISW AS SHOWN.**

**WHEN ROUTED CSX (via ISW intermediate):**

- Note 1 – Switch charges will be billed to the online ISW customer when not otherwise agreed. Switch charge monies are due and payable to ISW within 15 days of receipt of invoice, and/or all charges to be “PAID IN FULL” prior to rail cars moving offline, unless acceptable arrangements have been made for payment prior to final movement.
- Note 2 – Intermediate switch rates for ISW apply in each direction, unless otherwise noted. Such charges will be due and billed to the Rail Carrier as indicated above..
- Note 3 – No switching charges of the line haul charges will be absorbed by the ISW.
- Note 4 – No Intermediate switch charges will be absorbed by the ISW for cars moving to/from ISW to/from EVWR at Evansville, IN; Charges will be billed to the ISW customer.
- Note 5 – Subject to Rule 5 – Switching Car Hire Expense recovery – Code of Car Hire Rules and Interpretation as published in the Official Railway Equipment Register - Circular OT-10.
