THE FOLLOWING RULES AND CHARGES ARE APPLICABLE IN REGARD TO PARKING OF MOTOR VEHICLES, TRUCK TRAILERS, CONTAINERS, MOBILE EQUIPMENT OR OTHER PROPERTY ON KJRY RIGHT OF WAY.

PARKING

THIS TARIFF IS AUTHORIZED BY THE INTERSTATE COMMERCE ACT, AS AMENDED, 49 U.S.C. SECTION 10702.

RAILROAD RIGHT-OF-WAYS ARE AN INTEGRAL AND INDIVISIBLE COMPONENT OF THE RAILROAD'S TRANSPORTATION FACILITIES. UNAUTHORIZED OBSTRUCTIONS ON THE RIGHT OF WAY, INCLUDING UNAUTHORIZED PARKING OF MOTOR VEHICLES, TRAILERS, CONTAINERS, MOBILE EQUIPMENT OR OTHER PROPERTY CONSTITUTE THREATS TO THE SAFETY AND SECURITY OF RAILROAD OPERATIONS, AND TO PUBLIC SAFETY AT GRADE CROSSINGS, ETC. UNAUTHORIZED PARKING IS AN INTERFERENCE WITH INTERSTATE COMMERCE AND IS TRESPASSING.

THE FOLLOWING RATE SHALL APPLY TO ANY UNAUTHORIZED PARKING ON KJRY RIGHT OF WAY, AND WILL BE CHARGED **PER EACH AND EVERY** VEHICLE, TRAILER, CONTAINER, MOBILE EQUIPMENT, OR OTHER PIECE OF PROPERTY, UNTIL MOVED OR TOWED:

\$250.00 PER CALENDAR DAY, OR ANY PORTION THEREOF

KJRY RESERVES THE RIGHT TO TOW, AT OWNER'S EXPENSE, ANY VEHICLE AND/OR OTHER PIECE OF PROPERTY THAT IS PARKED WITHOUT AUTHORIZATION.

INSPECTION CHARGES MAY ALSO APPLY IF PARKING RESULTS IN POSSIBLE DAMAGE TO/IMPAIRMENT OF TRACK STRUCTURE, SIGNALS, CROSSING PROTECTION DEVICES, BRIDGES, CULVERTS, OR OTHER FIXTURES. SEE TARIFF FT-KJRY-9050.

RECEIPT OF OR PAYMENT OF CHARGES IN THIS TARIFF DOES NOT GRANT ANY PERSON A RIGHT TO ENTER UPON KJRY RIGHT OF WAY WITHOUT WRITTEN AUTHORIZATION.
